Vera Rises to the Challenge!

As part of Volunteers week all MP's throughout the country were challenged by Volunteer England to take part in voluntary activities within their constituency. Vera Baird QC MP for Redcar volunteered with Shopmobility. Here are her thoughts on the experience:

Vera & Ping in Redcar High Street

"I went shopping with Ping Bingham, a wheelchair user, on Friday. I enjoyed Ping's company and hope we can shop together again when my schedule permits. It was an eye-opener. She wanted sun cream, and I could have run up the steps to Boots in a minute from the Esplanade, but we had to go a couple of hundred yards round the block to their High Street entrance. Their shelves are at a good height for a wheelchair user, so she could pick her own cream. Other shops had narrow aisles and high counters. It is vital that wheelchair users are part of the planning of shops, offices, restaurants, pubs and all public places

For me, it was a chance to put myself in the position of a wheelchair user and understand how much harder it is to manage the ordinary things that I do so easily every day. Volunteering is a two-way process. I may have been the one doing the pushing, but Ping's good humour made the trip into an enjoyable outing for us both"

Do you know what a social enterprise is?

In the current funding climate it is important for voluntary and community organisations to look at a variety of ways to raise income. One avenue which you will probably have heard of is social enterprise. But what constitutes a social enterprise? The Department of Trade and Industry definition is:

"A social enterprise is a business with primarily social objectives whose surpluses are principally reinvested for that purpose in the business or in the community, rather than being driven by the need to maximise profit for shareholders and owners. Social enterprises tackle a wide range of social and environmental issues and operate in all parts of the economy.....Social enterprises are diverse.There is no single legal model for social enterprise.

Social Enterprise - a strategy for success DTI, 2004

The Office of the Third Sector has produced a document *Social enterprise action plan: Scaling new heights* which states that social enterprises range from small, community owned village shops to large development trusts. If you think you are already running a social enterprise or are considering setting one up this document is easy to read and includes definitions, case studies and guidance on running a social enterprise.

Voice4Change England: A new co-ordinated voice for the Black & Minority Ethnic Third Sector

Voice4Change England (V4CE) is a coalition of national and regional organisations which aims to provide a co-ordinated voice for the BME voluntary and community sector.

Procurement Assistance from Redcar and Cleveland Council Or "Are you Fit to Bid"

Allison Agius has been in post for the past six months as Procurement and Project officer at Redcar and Cleveland Borough Council. She has a lead in sustainability and part of her role is to explore the environmental, social and local economy impact of the council's procurement (purchasing) decisions.

One of the key areas Allison has been working on recently is making contact with organisations in the voluntary and community sector to explore the issues the sector has in doing business with the council.

She has offered advice on the procurement procedure to a number of organisations recently and, along with RCVDA, is currently exploring a range of options to assist the sector in the longer term.

This work is in the early stages and Allison is particularly interested in hearing from third sector organisations that either have ideas on how the council could help them, or would like some input from her on their current tendering processes.

She is also interested in developing a better understanding of the voluntary and community sector in the local area and the diverse organisations that make it what it is.

Sector could influence flow of unclaimed assets

Charities have a real opportunity to influence decisions regarding the distribution of unclaimed assets, according to Tom Eccles, secretary of the Commission for Unclaimed Assets, who is urging the sector to participate in the current consultation on the issue.

The joint consultation by HM Treasury and the Cabinet Office lays out the proposed spending priorities for the scheme. It currently focuses on youth services and financial capability and inclusion, with the social investment bank – a proposal favoured by many in the charity sector – taking a back seat. However, Eccles suggests that while the government was lukewarm towards the bank when the consultation document was published, there has since been a shift of opinion.

"There has been an improvement on where they were initially, people quibbled around the edges at first but the difficulties they raised can be resolved. There is enough money in the pot for both youth services and the social investment bank. I recommend that charities respond to the consultation in unequivocal terms as their response will help influence the amount each area receives."

However, as charities concern themselves with the distribution of the funds, a storm is brewing between the commission and the financial sector over exactly how the unclaimed assets scheme is to be regulated.

With government reluctant to legislate, a system of self-regulation looks set to be implemented. This, combined with the fact that tracking owners of dormant banks has cost implications for the banks and building societies, has led to concerns that they will be unwilling to participate or that transfers could be made fraudulently.

Reassurances from the British Bankers Association and Building Societies Association at a Treasury Select Committee meeting on 5 June did little to quash these fears, and the Commission on Unclaimed Assets emphasised the need for a self-regulator with "teeth".

"It's fine to go with self-regulation if we don't want regulation," said Sir Ronald Cohen, chair of the commission, at the Select Committee meeting. "But this regulator must have teeth. It's not enough to appoint a regulator who can make statements but has no power to enforce or investigate in order to make the scheme work."

The commission is recommending that the regulatory body be given three or four key powers, critically ones that enable it to request an audit on suspicion of incompetent or fraudulent activity. It has also suggested that as well as the power to fine banks found to be operating inappropriately, it should also be able to publish the details, as "public embarrassment and humiliation can be more effective".

A Cautionary Tale

This article appeared in a recent publication and I thought it was worth sharing.

"Recently, one of my charity clients found itself perched precariously on the horns of this dilemma: a dedicated and enthusiastic volunteer offered to realise part of its marketing strategy by creating a new website.

Many hours of unpaid labour resulted in a revitalised online presence that began to attract an increasing number of hits. Unfortunately, one of those hits was by an agency engaged by an international image library to protect its intellectual property.

In creating the website, the volunteer had uploaded images from the internet without making any investigations into their ownership. My client first became aware of this only when a letter from a New York law firm arrived threatening a five-figure legal action for copyright infringement. Suddenly, the free website didn't look so cost-effective."

Volunteering England observes: "The sector is working in a radically different climate from a decade or so ago, which has made risk a subject that all organisations need to consider."

Big Lottery Fund reveals revised funding schedule

The Big Lottery Fund has confirmed that it will "re-profile" £120m of its planned UK programmes over the coming year in order to meet its contribution to funding the 2012 Olympics. The two programmes affected both cater exclusively to voluntary and community organisations. The Young Peoples Fund 2, which was expected to be launched in April this year, will now be launched in two separate rounds, one in December and another next April. The Research Programme will now be launched in October 2007.

In a statement the Big Lottery Fund confirmed the delays but said the cuts did not constitute a cut in funding. Their statement said "Provided lottery income flows as expected, we will be able to make the commitments in 2008/09 or shortly afterwards".

When asked whether funding delays would cause third sector organisations to lose out, Stephen Dunmore, chief executive of the BLF said: "Our grants are time-limited and not designed to be a continuing source of income. Although the fund is one of the largest sources of income for the sector in the UK, groups cannot rely solely on lottery funding for income".

Are you smoke-free?



On 1st July 2007 nearly all enclosed and substantially enclosed workplaces (used by more than one person) and public places in England and Wales will become smoke-free. There are a number of provisions that you should be aware of. For example, indoor smoking rooms will no longer be allowed, so all smokers will need to go outside instead. In addition, you will need to display legally required signs at entrances to premises and in company vehicles used by more than one person. It is also advisable to have a written "smoke-free" policy in place.

Employers, managers and those in charge of smoke-free premises and vehicles will need to:

- display 'no-smoking' signs in smoke-free premises and vehicles
- take reasonable steps to ensure that staff, customers/members and visitors are aware that premises and vehicles are legally required to be smoke free
- remove any existing indoor smoking rooms
- ensure that no one smokes in smoke-free premises or vehicles

You may also want to take these supportive measures:

- remove ashtrays from smoke-free areas;
- develop a smoke-free policy in consultation with staff;
- offer staff training to help them understand the new law and what their responsibilities are;
- provide your staff and customers with support to quit smoking.

Employers and premises managers who do not comply with the new smoke-free law will be committing a criminal offence.

The Government has produced an official guide explaining the new law and what you will have to do to comply with it. This guide also includes a sample smoke-free policy. More information on the changes which come into effect on 1st July 2007, including the Government guidance, can be found at: www.smokefreeengland.co.uk

Lack of funds holds back green offices

Charities wanting to improve the green credentials of their office space do not have the funds or expertise to do so, according to a new report from Every Action Counts.

The survey of 442 voluntary organisations found that 89% would like to make their office 'greener', but 84% said the cost of making changes was holding them back. More than half (61%) also said that a lack of knowledge or signposting was also reducing their ability to improve their eco-standards.

Many organisations already admitted to taking small steps; 74% said they already ensured all computers and lights were switched off when they left the building.
