JOB PURPOSE:

The Sport Welfare Officer is responsible for acting as a source of advice and support about safeguarding and protecting children, young people and adults at risk in the local sports community, focusing on promoting good practice to create safe and positive environments where everyone can feel the benefits of an active life.

Duties and Responsibilities

- Support Welfare Officers in sports clubs and National Governing Bodies plus some community groups to progress from welfare compliance to an effective welfare culture
- To deliver training for local sports clubs and community groups to embed good welfare practice with safe environments for participants
- Promote best practice guidance alongside inclusive practice
- Establish a forum to facilitate effective communication on safeguarding topics
- Facilitate and support reporting and referral of safeguarding cases from local to national and, if appropriate, support resolution of lower level concerns
